REIT issued 1,777,917 new units at US\$0.456 per unit pursuant to its Distribution Reinvestment Plan ("DRP") on 28 March 2024 in respect of the distribution of US 2.14 cents per unit for the period from 1 July 2023 to 31 December 2023, and the total number of issued units of REIT increased from 581,668,324 to 583,446,241 as a result. Kuang Ming did not elect to participate in the DRP. Consequently, there was a decrease in Kuang Ming's percentage interest in REIT and it ceased to be a substantial unitholder in REIT.
